#### Stainless Trim Repair & Polishing

Let me begin by saying, I am not a professional at this, only a hobbyist that likes doing as much as I can on my own cars. There are probably hundreds of videos showing different methods on repairing and polishing stainless. This is the method that I use. Stainless repair and polishing is a long drawn out process, it take time and you cannot rush the process. I can easily spend hours on just one piece.

First you should clean your trim so that you can easily see the scratches and dent that are in the metal.

You will need a trim anvil and a small chisel hammer, a fine file, and 80, 150, 220, 320, 400, 600, 1000, and 2000 grit sandpaper. Additionally, you will probably need a flat blade screwdriver and an old wood chisel with the sharp edge ground down to a flat surface.

If the trim is dented, gently tap out the dent on the trim anvil. Next, file the area that you just removed the dent, with your file. This step will expose the high and low spots. If low, return to the anvil and hammer some more. For dents close to a folded edge, use the flat blade screwdriver to lift the edge so you can reach the dent with your chisel hammer. In areas where the hammer won't reach, you can use a chisel or small screwdriver to knock out the dent.



If there is a gouge and not a dent, use the chisel hammer to lightly tap out the damaged area. You will have to tap out the area so that it is raised higher than the rest of the trim surface, so that you can hammer it down and file the gouged area smooth.

After all of the dents have been removed, I will sand using 80 grit sandpaper over the filed areas to sand out the marks left by the file. I will then sand over the 80 grit sanding marks with 150 grit paper to sand out the 80 grit sanding marks.


#### Stainless Trim Repair & Polishing (continued)

Next, I will sand the entire piece with 220 grit paper. Then move to 320, 400, 600, 1000, and finally 2000 grit paper. Each finer grit of sandpaper sands out the previous grit's sanding marks. I have learned the hard way, that when you think your are finish with a particular grit of paper, grab another piece and sand again, and again. After you sand with 2000 grit, you are ready for polishing.

I use a ½ hp buffing motor that accepts 6" buffing wheels. You can get larger motors that accept 8" or 10" wheels. When buffing you should only use the bottom edge of the wheel to prevent kick-back and damage to your trim piece.

The first wheel that I use is a sisal wheel. It is used for coarse cutting and removal of any scratches that may be left after the sanding process. Emery compound is used with this wheel. I move the trim piece in one direction, pushing not pulling against the wheel. You will need a good pair of gloves, a full-face shield, and I also wear an apron when polishing. I do the entire piece at least 3 times. Go slow, do not rush the process.



The next wheel I use is a spiral-sewn wheel for medium cutting. White stainless compound is used with this wheel. It is important **not** to contaminate your wheels. By this I mean do not use different compounds on the same wheel. It is important to clean your piece thoroughly before moving to the next wheel. Again, you should push the trim through the wheel. Do not pull it. And as before, I do the entire piece at least 3 time.

Finally, I use is a loosely-sewn wheel for final polishing. With this wheel I use a white rouge compound. I follow the same process used on the first two wheels, pushing not pulling the piece. When you are finished, you should have a brilliant mirror finish, dent free piece of trim.

#### 1961 Corvette in North Mississippi

I've had a busy November. Earlier this month I discovered a 1961 Corvette in north Mississippi. The car, VIN #10867S103970, was manufactured in December 1960 and delivered to a Chevrolet dealer, Mitchell Motors, in West Point, Mississippi. The car was purchased by the original owner, Charles Eudy, in early 1961 and was actively driven until 1973 when it was put into storage. Mr. Eudy died this summer, and the family needed the car removed from a large building on family land that was being sold. Thanks to the encouragement and invaluable assistance of fellow NCRS member, Ken Walley, I was able to acquire the car. It took Ken and me about 3 hours just to clear out all the material around the car, then another hour to put the car in Ken's trailer for transport.

The numbers matching car is sateen silver with a red interior and is "in the rough" but largely original. The motor is the base 283 cu in 230 hp with a 4-speed and positive traction rear end. The only other accessories are an AM radio and heater. The car has a trailer hitch and routinely towed a fishing boat to Grenada Lake in north Mississippi. As you can see in the pictures, the Corvette was also used for deer hunting.








#### 1961 Corvette in North Mississippi (continued)

#### **NCRS Chapter Award Program**


#### Variable Activities for the year

- 2V Six technical articles must be published in the Chapter Newsletter
- 3V A total of 15% or more of the Chapter members and/ or family members must judge or tabulate at the Judging Meet(s). Each person can only be counted once during the year
- 4V A total of 15% of Chapter members must drive their Corvette(s) to a Chapter meeting or Chapter event during the year. The Chapter Road Tour is not included. Each person can only be counted once during the year
- 5V Chapter Road Tour must include at least 5% of the members cars
- 6V At least 20% of the Chapter members must attend one or more Chapter meetings or events
- 7V Set up NCRS display at a Non-NCRS event
- 8V A charitable donation of \$100 or more is donated to a 501-3C qualified charity


